

SUBJECT: Report on Major Achievements & Important Policy Decisions of NATRIP for m/o September, 2018.

Major Achievements & Important Policy Decisions:

- 1. Governing Council in its 64th meeting on 18th July 2017 decided to explore possibilities of operating all four fully funded NATRIP centers viz. GARC-Chennai, NIAIMT-Silchar, ICAT-Manesar & NATRAX-Indore on Public Private Partnership (PPP) basis. Accordingly, Expression of Interest (EOI) was floated on 18th August, 2017 to identify a Consultant (Transaction Advisor) and after Techno-commercial and Financial bid evaluation and due acceptance of GC, LOA was issued to M/s Ernst & Young LLP on 23th October, 2017 and agreement was signed on 08th November, 2017. M/s E & Y had submitted the final draft on 15th June, 2018. The same had been examined and comments conveyed to M/s E&Y. On 05th July, 2018 M/s E & Y had submitted revised final draft feasibility report after incorporating the comments which had been discussed widely after examination. The second meeting of Transition Monitoring Committee (TMC) to consider final draft feasibility report was held on 08th August, 2018 wherein it was advised to take the matter to DHI through GC. Accordingly, matter was placed before GC, NATIS in its 66th Meeting held on 24th September, 2018 and the same would be submitted to DHI upon finalization of minutes.
- 2. In order to ensure compliance with guidelines issued by the Official Language Department to promote the use of Hindi as official language in official functioning, NATRIP had celebrated the Hindi Pakkhwara from 01st to 15th September, 2018. The various fortnightly competitions were organized to increase the interest in the use of Hindi language for the officers and employees during the campaign. The activities were done; (i) Essay competition (ii) letter writing (iii) Speech competition (iv) Translation competition.
- 3. The Governing Council in its 66th Meeting held on 24.09.2018 accorded approval to forward the application of NATRAX, Indore to Ministry of Road Transport and Highways seeking Notification of NATRAX as a Type approval & Homologation Test agency under



Rule 126 of Central Motor Vehicles Rules (CMVR), 1989. It will help center to generate revenue and become self sustainable. Auto Industries located in the area will also stand to gain.

- 4. A premier annual event of 3rd Catalyst Conference was organized by ICAT, Manesar in association with Altius Auto Solutions Pvt. Ltd on growth in E-Vehicle Industry. The event was inaugurated by the Union Minister for Heavy Industries and Public Enterprises Shri Anant G. Geete on 21st September, 2018 in Bengaluru.
- 5. NIAIMT-Silchar under NATRIP and Indian Auto Company (IAC) with Society of Indian Automobile Manufacturers (SIAM) as the knowledge partner jointly launched the first certificate course on "Automotive Telematics and GPS" at NIAIMT-Silchar in an event organized on 11th September, 2018. The course will open up fresh opportunity for the youth of North-East region of the country in the field of GPS and Vehicle Tracking System, a rapidly emerging field in Vehicle Safety. Consequently, total 10 candidates (two batches of 5 candidates) have been trained in aforesaid course in September, 2018.
- NIAIMT, Silchar undertook a batch of 18 candidates under Fresh LMV (Non Transport)
 driving category in September, 2018. Total 131 candidates have been trained under this
 category in FY 2018-19.
- 7. NIAIMT, Silchar reported that the training of 3 candidates under LMV (Non-Transport to Transport) category for conversion of their license from Non-Transport to Transport category has been completed in September, 2018. Total 18 candidates have been trained under this category FY 2018-19.
- 8. In response to the first stake holder meeting held on 01st May, 2018 and third stake holder meeting held on 14th July, 2018, total 17 nos of commercial vehicles have been tested during the September, 2018 at Inspection & Maintenance Station (IMS), NIAIMT. The Ten (10) nos of vehicles were from Transporter associations and seven (7) nos were from CRPF, Dayapur.
- 9. GARC, Chennai has reported the significant development in the work of Advance Passive Safety Lab (APSL) (i) The casting of RCC columns and Tie beams up to 8mtr level and Brick work enclosure as per M&E supplier M/s Messring has been completed in Main Crash Area (MCA). (ii) The Foundation work and RCC column with Tie beam up to 3mtr level has been completed in Angular Crash Area (ACA).
- 10. GARC, Chennai has reported the significant development in the work Electromagnetic Compatibility Lab (EMC) lab (i) The Third party RF shield testing (10KHz to 18GHz) for the

- 11. GARC, Chennai has reported that the mechanical & electrical installation of Variable Volume Variable Temperature Sealed Housing Evaporation Determination (VVVT SHED) has been completed by M/s Webber in Powertrain (PWT) Lab.
- 12. GARC, Chennai has reported the mechanical installation of (i) Seat belt anchorage: equipment evaluates proper function of the seat belt system, when the defined static test loads that represent the vehicular impact is applied on the seat belt anchorage, (ii) Cab pendulum: equipment is used for checking the survival space of occupant inside the cabin of vehicle during an impact, (iii) Drawbar & Draw beam: equipment is used for testing the maximum permissible load applied on drawbar and draw beam in trailers and semi trailers has been completed by M/s Sushma Industries in Certification Lab.
